## TERMS AND CONDITIONS

By submitting an application and executing this Release, Entrant acknowledges and agrees to be bound by the following terms and conditions:

1. Entrant acknowledges and agrees that he/she is not entitled to any monetary, in-kind, or other type of compensation of any kind by virtue of submitting an application to the Biz Pitch or providing any additional documents in support of the application (hereafter, collectively, "Submitted Material"). Without limiting the foregoing, Entrant specifically agrees that he/she does not have and will not have or assert any so-called "idea submission" or similar claim against SRI, and their agents, employees, representatives and volunteers, including but not limited to the judges chosen for the Biz Pitch and that the SRI is free to use the materials submitted by the Entrant in any manner it sees fit. Entrant acknowledges and agrees that the submission of the Submitted Material and participation in the Biz Pitch does not create any relationship of trust or confidentiality, including but not limited to a fiduciary relationship of any kind.
4. Entrant warrants and represents that he/she is the sole owner of the Submitted Material and/or has obtained all necessary permissions (including but not limited to applicable licenses) to grant the SRI the rights and offer the releases described herein.
