VENDOR RULES AND REGULATIONS

Saturday, September 17, 2022 | 1:00pm to 5:00pm

1. The festival will be held rain or shine.
2. Setup is from 9AM-12 Noon on Saturday. Vehicles must be removed from the riverfront festival area by 12 noon, no exceptions.
3. Tear down begins no earlier than 5:00PM. Vehicles will not be permitted in the festival area until the area has been cleared of all pedestrians.
4. One (1) eight (8) foot table and two (2) folding chairs will be provided per 10x10 space. Vendors must supply their own tent.
5. Please do not overload the electrical outlets, only one appliance per plug. Multiple cords and power strips are prohibited.
6. All decisions of Sunbury's Revitalization, Inc. and the Event Committee are final.
7. Indemnification - In consideration of the use of event space designated for vendors by Sunbury's Revitalization, Inc. ("SRI"), the undersigned ("Vendor") hereby agrees to release Sunbury's Revitalization, Inc., the City of Sunbury, Lake Augusta Wine & Brew Festival, and Event Sponsors, their Board of Directors, officers, members, employees, volunteers, and agents from all claims whatsoever by Vendor arising from or related to Vendor's use of space.
8. Vendor further agrees to hold harmless, to defend and indemnify, dollar for dollar including, but not limited to costs of defense and counsel fees, Sunbury's Revitalization, Inc., the City of Sunbury, Brews on Lake Augusta Wine & Beer Festival, and Event Sponsors, their Board of Directors, officers, members, employees and agents against any and all liability, law suits, claims, summons, causes of action or things whatsoever, whether for damages, fines or any other type of relief whatsoever, that may be brought against Sunbury's Revitalization, Inc., the City of Sunbury, Brews on Lake Augusta Wine & Beer Festival, and Event Sponsors, their Board of Directors, officers, members, employees and agents by any party whatsoever, arising from or related to Vendor's and/or its directors, officers, employees and agents activities, products, acts or omissions, whether negligent or non-negligent.
9. All Vendors - Certification of Insurance - Provide a Certificate of General Liability Insurance naming Sunbury's Revitalization, Inc. and Lake Augusta Wine & Brew Festival as "Additional Insured regarding vendor participation at Lake Augusta Wine & Brew Festival on September 17, 2022", providing a minimum of \$1,000,000 liability coverage. Limited exclusions may apply.
10. Alcohol Vendors - Certification of Insurance - Provide a Certificate Of Liquor Liability Insurance naming Sunbury's Revitalization, Inc. as "Additional Insured regarding vendor participation at Lake Augusta Wine & Brew Festival on, September 17, 2022" providing a minimum of \$1,000,000 liquor liability coverage.
11. Anyone serving alcohol must be over 21 years of age and be RAMP trained.
12. Food Vendors must provide a copy of a valid Servsafe Certificate. Food Vendors must also display prices at the event.
13. SRI, the City of Sunbury, Lake Augusta Wine & Brew Festival, and Event Sponsors, their Board of Directors, officers, members, employees, volunteers, and agents will not be responsible for theft, accidents or loss, or damage to property belonging to Vendors.

16. Vendors are responsible for all state sales tax and compliance with any/all PLCB requirements for attending the event.
